I, the undersigned, in consideration of enrollment for training in the Permian Basin Obedience Training Club, do hereby agree that I release and waive any right that I (or any member of my family) may have in law to recover medical payments, property damages, or bodily injury damages for any liability regardless of cost, provided that liability is due to ordinary negligence (this release does not contemplate wanton, willful, or malicious conduct) as a result of any injury that I (or any member of my family) may sustain from any other dog or my own dog, dogs, or property belonging to me, within the limits of the PBOTC training area.

I further agree that I hereby release and waive any right that I (or any member of my family) may have at law, to hold PBOTC and/or owners of the premises, liable to any injury or damage which may occur to me or my dog, dogs, or property, provided this injury or damage is due to ordinary circumstances of negligence.

I further agree that I will assume the risks of participation in obedience training where there are other dogs whose temperaments are unknown to me; that I assume full responsibility for any injury which may occur to me (or any member of my family), my dogs, or damage to my property as a result of such participation in this class, and in the event that any injury or damage occurs to me (or any member of my family), my dog, dogs or property, or that any damages would ordinarily be due to me, that I waive any right that I may have to bring suit or other proceedings to recover therefor.

I have read this paper and am fully aware that this contract constitutes a waiver and release of any and all liability as a result of any injury to me (or any member of my family), my dog, dogs or damage to my property.
